The Virginia Department of Transportation (VDOT), in partnership with Gloucester County, is holding a public information meeting to share potential improvements proposed by two transportation studies underway in Gloucester County.

The purpose for both studies is to develop concepts for future funding applications. Draft concepts for potential future projects are being presented for public comment before the study reports are finalized. The studies do not propose timelines for construction for any potential future improvements.

One study evaluated Route 14 between Route 17 Business (Main Street) and Ware Neck Road as part of VDOT's Strategically Targeted Affordable Roadway Solutions (STARS) program. An online survey will be posted the day of the meeting:

A second, separate study evaluated Route 17 between McFadden Way/Hospital Drive and Belroi Road, and Route 17 Business (Main Street) between Route 17 and Justice Drive, as part of the Project Pipeline program.
